Though we face continued challenges, let us take this opportunity to rededicate ourselves to strengthening the IAEA and its vital role in preventing proliferation, addressing noncompliance, and expanding access to the peaceful uses of nuclear energy.

Allow me to extend on behalf of the Government of Palau highest appreciation to the European Union and all the donor countries who have risen to the challenge and have been supporting the IAEA's Peaceful Uses Initiative (PUI) to benefit more member states. Palau thanks Director General Amano for his outstanding leadership in the effort to drive resources and focus toward supporting global economic development goals. Palau has benefited while focused to improve its agricultural productivity, food security, health and nutrition, better management of underground water resources, environment, air pollution, marine coastal areas, sustainable energy development, radiation infrastructure safety, nuclear safety and security.
