Abstracts (max. 500 characters) should be written in English and entered as plain text in the HTR2021 submission system. Once accepted, full papers are submitted electronically in Adobe Acrobat (PDF) or Microsoft Word format using the HTR2021 template.

# **ACCEPTANCE CRITERIA:**

Paper acceptance will be based upon originality of the work, strictly implemented methods or models, quality of results, impact of the scientific advances, conclusions supported by data, proper citing of references, and use of correct grammar and spelling.
