- Access to the VIC:** Please be aware that due to construction work on the U1 line, the stop “Kaisermühlen/VIC” will be closed in the direction of Leopoldau from 25 April – 07 August 2022. This means trains will not stop at the VIC. As an alternative, passengers can travel one stop further to “Alte Donau” and then take the train back one stop to “Kaisermühlen/VIC”.
