- 1 On 19 June 1997, the People's Republic of China notified the Agency that the RSA applies to the Hong Kong Special Administrative Region as from 1 July 1997. In accordance with a notification by the United Kingdom of Great Britain and Northern Ireland, dated 19 June 1997, the RSA signed by the United Kingdom for Hong Kong was terminated as of 1 July 1997.
  - 2 The RSA was originally concluded by the Czech and Slovak Federal Republic on 20 September 1990. The Czech Republic notified its succession in respect thereof on 1 July 1998.
  - 3 The RSA was originally concluded by the Socialist Federal Republic of Yugoslavia and entered into force on 20 July 1990. On 28 April 1992, the Federal Republic of Yugoslavia (Serbia and Montenegro) notified its continuation in respect thereof. The Republic of Montenegro notified its succession in respect thereof on 22 March 2007.
  - 4 The RSA was originally concluded by the Socialist Federal Republic of Yugoslavia and entered into force on 20 July 1990. On 28 April 1992, the Federal Republic of Yugoslavia (Serbia and Montenegro) notified its continuation in respect thereof. On 2 July 2006, the Republic of Serbia notified its continuation in respect thereof.
