



Protocol to Amend the Vienna Convention on Civil Liability for Nuclear Damage

Notes: The Protocol was adopted on 12 September 1997 and entered into force on 4 October 2003, in accordance with Article 21, paragraph 1. For States depositing an instrument expressing consent to be bound after that date, the Protocol enters into force three months after such deposit, in accordance with Article 21, paragraph 2.
