



Convention on Early Notification of a Nuclear Accident

Notes: The Convention was opened for signature in Vienna on 26 September 1986 and in New York on 6 October 1986, and entered into force on 27 October 1986 in accordance with Article 12, paragraph 3. For each State or organization depositing an instrument expressing consent to be bound after that date, the Convention enters into force thirty days after such deposit, in accordance with Article 12, paragraph 4.

- 1 The Socialist Federal Republic of Yugoslavia had signed and ratified the Convention on 27 May 1987 and 8 February 1989, respectively.
- 2 The Czechoslovak Socialist Republic had signed the Convention, not subject to ratification, on 26 September 1986. A reservation concerning Article 11, paragraph 2, of the Convention, which had been made upon signature, had been withdrawn on 6 June 1991 by the Czech and Slovak Federal Republic.
- 3 Signature not subject to ratification, acceptance or approval, in accordance with Article 12, paragraph 2, of the Convention.
- 4 The Convention was signed and ratified by the Federal Republic of Germany, which declared upon ratification that the Convention would also apply to "Land Berlin". The German Democratic Republic had also signed and ratified the Convention on 26 September 1986 and 29 April 1987, respectively, with a reservation concerning Article 11, paragraph 2. On 9 October 1990, the Federal Republic of Germany notified the Depositary that, following the "accession" of the German Democratic Republic to the Federal Republic of Germany with effect from 3 October 1990, the international treaties and agreements to which the Federal Republic of Germany was a contracting party would also apply to the territory of the former German Democratic Republic.
- 5 The Socialist Federal Republic of Yugoslavia had signed and ratified the Convention on 27 May 1987 and 8 February 1989, respectively. The Federal Republic of Yugoslavia (Serbia and Montenegro) had notified the Depositary of its succession to the Convention, with effect from 27 April 1992.
- 6 The instrument of acceptance specified that acceptance was "for the Kingdom as a whole". In view of successive constitutional modifications, on 6 June 2011, the Netherlands provided the Depositary with a status report whereby the Convention applies to: The Netherlands (European part) as of 24 October 1991, the Caribbean part of the Netherlands (the Islands of Bonaire, Sint Eustatius and Saba) as of 10 October 2010, Aruba as of 24 October 1991, Curaçao as of 10 October 2010 and Sint Maarten as of 10 October 2010.
- 7 The instrument of accession specified that the Convention would extend to the Cook Islands and to Niue.
- 8 The Convention was signed and ratified by the Union of Soviet Socialist Republics (USSR). On 26 December 1991, the Russian Federation notified the Depositary that the participation of the USSR "in all conventions, agreements and international legal instruments which were concluded within the Agency's framework or under its aegis is continued by the Russian Federation".
- 9 The Socialist Federal Republic of Yugoslavia had signed and ratified the Convention on 27 May 1987 and 8 February 1989, respectively. On 28 April 1992, the Federal Republic of Yugoslavia (Serbia and Montenegro) notified the Depositary that it intended to "continue to fulfil the rights conferred and obligations assumed by the SFRY in international relations", including "participation in international treaties acceded to by Yugoslavia. Subsequently, on 5 February 2002, the Federal Republic of Yugoslavia (Serbia and Montenegro) deposited a notification of succession to the Convention, with effect from 27 April 1992. On 2 July 2006, the Republic of Serbia notified the Depositary that it intended "to continue to exercise its rights and honour its commitments deriving from international treaties concluded by Serbia and Montenegro."
