To effectively realize the vision of AFCONE, the CSP resolved the dismissal of the former AFCONE Executive Secretary.

In this regards, a new interim Executive Secretary has been appointed.

On the other side, I am pleased to inform you that the 16th Anniversary of the entry into force of the Pelindaba Treaty was commemorated on 30th July 2025. The celebration marked a decade of promoting nuclear nonproliferation, nuclear disarmament, coordination of nuclear energy and applications across the Africa continent for peaceful purposes.

AFCONE stands proud as the custodian of the Pelindaba Treaty, which is Africa's Pride and a major milestone for promoting peace, security and nuclear technological development in Africa.

Disarmament and Non-Proliferation is a key priority of the African Continental Agenda to enhance regional and global security. While most African Member States have ratified global and continental instruments, there is need to address implementation gaps, contributed by limited human expertise and financial resources dedicated to implementation.

In furtherance of this goal, AFCONE in July 2025, working alongside the African Union Commission (AUC) engaged African Member States in Addis Ababa, in raising awareness in meeting their obligations relating to regional and global instruments concerning nuclear Weapons.

Additionally, AFCONE alongside African Union (AU) in July 2025, launched an "African Fellowship Program in Disarmament and Non-Proliferation", to increase the knowledge and skills in arms control, Diplomatic negotiation and peaceful use of nuclear technology. The program will serve as a platform for training and capacity building for experts, policy makers and diplomats.

Mr. President,

African continent is experiencing increase interest and activities in nuclear applications, driven by energy security needs and potential for sustainable development. To benefit from nuclear technology, African Member States must demonstrate commitment for effective nuclear regulatory controls and safeguards.

Therefore, in pursuit of establishing and improving nuclear safeguards in the Africa region, AFCONE is delighted to report that it is currently implementing nuclear material accounting and control systems for African Member States, with the help of European Union and the Republic of Finland. The training program will address sustainability of African states in attaining critical pre-requisites component of the international security framework.

African development can be significantly advanced by nuclear science and technology, with vital applications opportunities available in healthcare, agriculture, food security, energy and industrial applications.

In this regard, AFCONE collaborates with IAEA to support African Member States leverage on nuclear science and technology for sustainable development, focusing on capacity building, knowledge sharing and project implementation.

We are pleased to inform you that AFCONE collaborative efforts with IAEA is already bearing fruits. In 2025, IAEA supported AFCONE with specialized work force, planning and modeling tools to support programs in nuclear energy, safeguards, nuclear science and technology.

African representation in nuclear science and technology is unevenly distributed, with women and youth significantly under-represented.

Alongside with Women in Nuclear Africa (WINS), and the African Young generation in nuclear, AFCONE is engaged to provide a platform for dialogue and collaboration for both Women and youth to increase the level of representation in the nuclear industry in Africa.
