### PROVISIONAL AGENDA

### Note by the Director General

1. Pursuant to Rule 2 of the Rules of Procedure of the General Conference  $\frac{1}{2}$ , the Director General hereby notifies all Members of the Agency that the ninth regular session of the General Conference will begin on Tuesday, 21 September 1965. As indicated in document GC(IX)/INF/79, paragraph 3, the Conference will meet at the Tokyo Prince Hotel at 3, Shiba Park, Tokyo.

2. In consultation with the President who held office during the eighth regular session of the Conference, the Director General is calling the opening meeting for 11.45 a.m. At this meeting it is foreseen that, following a welcoming address by a representative of the Host Government, the Temporary President will invite the Conference to elect its President, and that the President will thereafter adjourn the meeting. The Conference will then reconvene in plenary meeting later in the afternoon to take up such other business as is normally dealt with on the first day of a session.

3. In accordance with Rule 11 the Director General has drawn up the attached provisional agenda for the session in consultation with the Board of Governors. In the annotations thereto a suggestion is made against each item, for consideration by the General Committee, as to where the item should first be discussed - in plenary meeting or in one of the committees. The allocation of particular numbers to items should not be construed as a formal proposal that the items should be discussed in that order; the numbers do, however, largely reflect the order in which the Conference took up corresponding items at previous sessions. The Conference may accordingly find it convenient to take items 1-11 during the first series of plenary meetings; items 12-20 are grouped according to the committee in which it is suggested they should first be discussed; and the remainder are those which it seems likely the Conference will wish to take up in the second series of plenary meetings in the latter half of the session.

4. Should the Director General receive by 22 August any request under Rule 13 for the inclusion of supplementary items in the agenda, such items will, subject to the limitation in Rule 21, be placed on a supplementary list of items which will be circulated not later than 1 September.

### ANNOTATIONS

### 1. Opening of the session

In the light of Rule 33 of the Rules of Procedure, it is expected that the session will be opened by the delegate of the Netherlands. Immediately thereafter the presiding officer will invite the delegates to observe a minute of silence dedicated to prayer or meditation (Rule 48).

### 2. Election of the President

Under Rule 34 the General Conference is required to elect a President to hold office until the end of the session.

3. Credentials of delegates to the ninth regular session

### (a) Appointment of the Credentials Committee

Under Rule 28 the President will propose the appointment of a Credentials Committee of nine Members.

(b) Report of the Credentials Committee

Under Rule 28 the Credentials Committee is required to examine the credentials of all delegates and report thereon to the General Conference.

4. Election of the Vice-Presidents

Under Rule 34 the Conference is required to elect eight Vice-Presidents to hold office until the end of the session. $\frac{2}{}$ 

### 5. Appointment of the General Committee

Under Rule 40 the Conference is required to appoint a General Committee consisting of the President, the eight Vice-Presidents, the Chairman of the Main Committees and four additional members.

6. Applications for membership of the Agency

This item is included for the contingency that the Conference may have before it one or more recommendations by the Board of Governors for the admission to membership of the Agency.

7. Statement by the Director General

The Director General proposes to make an oral statement to the Conference.

Before this item is taken it will accordingly be necessary to hold brief meetings of the two Committees (the Programme, Technical and Budget Committee and the Administrative and Legal Committee) at which these two bodies can elect their respective Chairmen.

### 8. Adoption of the agenda and allocation of items for initial discussion

The General Committee will report to the Conference under Rule 42(a) on the provisional agenda set forth in the present document and on any supplementary list of items (Rule 13); it will also report on any proposals for the inclusion of additional items of an important or urgent character in the agenda (Rule 15) that may have been made at the outset of the session. After considering this report, the Conference will approve the agenda (Rule 14) and allocate the items for initial discussion.

### 9. Closing of the session

Under Rule 8 the Conference is required to fix a closing date for the session, after considering a recommendation on the subject which the General Committee will make.

10. General debate and report of the Board of Governors for 1964-65

Under Article V.E.4 of the Statute the Conference is required to consider the annual report for the year 1964-65 which the Board has prepared (document GC(IX)/299). It is suggested that, after the Conference has first taken the report in plenary, any matter which calls for more detailed consideration could be referred to a Committee, which could later submit its recommendations thereon to the Conference in plenary meeting.

Opening date of the tenth regular session 11.

Under Rule 1 the General Conference is required to set the opening date of the tenth regular session.

#### 12 Election of Members to the Board of Governors

The terms of office of Afghanistan, China, the Democratic Republic of the Congo, Morocco, Romania, Switzerland and Uruguay as elected Members of the Board will expire at the end of the ninth regular session of the Conference. Under Rule 86 the General Comittee is required to determine the number of elective places on the Board to be filled by the Conference so that, after the end of the session, the Board will be constituted in accordance with the provisions of Article VI, A. 3 of the Statute. Rules 79-81 and 83-88 relate to the conduct of the elections, and the Members elected will hold office until the end of the eleventh regular session (Article VI. D of the Statute and Rule 84).

13. The Agency's budget for 1965

In document GC(IX)/296 the Board is submitting to the Conference a supplementary estimate for the administrative expenses of the Agency during the current year.

14. The Agency's budget for 1966

Under Article V.E.5 of the Statute the Conference is required to approve the Agency's budget for 1966 on the basis of estimates for expenses which the Board is submitting to it under Article XIV. A in document GC(IX)/300, or to return the budget with recommendations as to its entirety or parts to the Board, for re-submission to the Conference.

This item is included to cover the eventuality that the Board may decide to submit to the Conference a draft treaty instrument on emergency assistance in the event of radiation accidents.

#### Administrative and 20. The Agency's relations with intergovernmental Legal Committee organizations

In line with the authorizations the Conference has previously given to the Board to invite particular intergovernmental organizations to be represented at its sessions $\frac{3}{2}$ , the Board is seeking in document GC(IX)/297 a similar authorization in respect of the tenth session. It is also possible that under this item the Conference will have before it a recommendation made by the Board in the light of Resolution GC(VIII)/RES/179.

21. Appointment of the Director General

The period of appointment of the present Director General ends on 30 November  $1965^{4/}$ . In document GC(IX)/304 the Board is seeking the Conference's approval, pursuant to Article VII. A of the Statute, of the appointment of Dr. Sigvard Eklund it has accordingly made to the post.

#### 25. Closing of the session

Under Rule 48 the President will invite the delegates to observe a minute of silence dedicated to prayer or meditation, and immediately thereafter declare the session closed.
