THE AGENCY'S BUDGET FOR 1966

First report of the Programme. Technical and Budget Committee on agenda item 14

Rapporteur: Mr. B. TORKI (Tunisia)

1. At its sixty-fifth meeting held on 24 September 1965, the Committee considered the Agency's budget for $1966^{1/2}$.

2. The Chairman recalled that last year the General Conference had considered the biennial programme for 1965 and 1966 and had adopted the budget for 1965. The estimates for 1966 were therefore based on the requirements for the second year of this biennial programme.

3. On the proposal of the Chairman, the Committee held a general debate, in the course of which a number of suggestions were made regarding the implementation of the programme.

4. At the conclusion of the discussion, the draft resolutions set forth in Annex IV to document GC(IX)/300 were voted upon separately with the results indicated below:

Draft resolution A relating to Regular Budget appropriations for 1966 was approved by 37 votes in favour, one against, with 10 abstentions. Draft resolution B relating to Operational Budget allocations for 1966 was approved by 42 votes in favour, none against, with 5 abstentions. Draft resolution C relating to the use of the Working Capital Fund in 1966 was approved by 46 votes in favour, none against, with one abstention.

5. As a result of the decisions taken, the Committee recommends for adoption by the General Conference the resolutions contained in Annexes I - III to the present report.

ANNEX I

REGULAR BUDGET APPROPRIATIONS FOR 1966

The General Conference.

<u>Accepting</u> the recommendations of the Board of Governors relating to appropriations of funds for the Regular Budget of the Agency in $1966^{1/2}$,

1. <u>Appropriates</u> an amount of US \$8 744 000 for the administrative expenses of the Agency in 1966 as follows:

2. Decides that the foregoing appropriations shall be financed as follows:

(a) US \$140 000 from miscellaneous income;

(b) US \$152 500 from the Special Account of the United Nations;

(c) US \$25 000 from the Publications Revolving Fund; and

(d) US \$8 426 500 from contributions by Member States on the basis of a scale of assessments to be determined by the General Conference, the contributions being adjusted pursuant to the Agency's Financial Regulations²/to take account of the cash surplus for 1963; and

3. <u>Authorizes</u> the Director General, with the prior approval of the Board of Governors, to make transfers between any of the sections listed in paragraph 1 of this resolution.

ANNEX II

OPERATIONAL BUDGET ALLOCATIONS FOR 1966

The General Conference,

(a) <u>Accepting</u> the recommendations of the Board of Governors, relating to the Agency's operational programme in $1966^{1/}$,

(b) <u>Noting</u> that funds from various sources, estimated at US \$478 000, are expected to be available for that programme,

1. <u>Decides</u> that for 1966 the target for voluntary contributions to the General Fund shall be US \$2 000 000;

2. <u>Urges</u> all Member States to make voluntary contributions to the General Fund for 1966 in accordance with Article XIV.F of the Statute and with the terms of paragraphs 2 and 3 of its resolution GC(V)/RES/100, so that this target may be reached;

3. Allocates the following sums for the Agency's operational programme in 1966:

4. <u>Authorizes</u> the Director General to employ staff and incur other expenditure for the Laboratory in addition to that for which provision is made in the budget for 1966, provided that the emoluments of such staff and other costs are met from revenues arising out of work performed in the Laboratory for Member States, research grants, special contributions or other sources extraneous to the Regular and Operational Budgets for 1966.

ANNEX III

USE OF THE WORKING CAPITAL FUND IN 1966

The General Conference.

<u>According</u> the recommendations of the Board of Governors relating to the use of the Working Capital Fund in $1966^{1/3}$;

1. Decides:

(a) That the Working Capital Fund of the Agency shall remain at US \$2 million in 1966; and

(b) That the Fund shall be financed, administered and used in 1966 in accordance with the relevant provisions of the Agency's Financial Regulations^{2/}.

2. <u>Authorizes</u> the Director General:

(a) To make advances from the Fund, not exceeding US \$25 000 at any time, to provide temporary financing for projects and activities of a strictly selfliquidating character which will not necessitate an increase in the Fund in future years; and

(b) With the prior approval of the Board of Governors, unless in his opinion the situation requires immediate action before such approval can be obtained, to make advances from the Fund to meet the cost incurred by the Agency in organizing and rendering emergency assistance to Member States in connection with radiation accidents, up to \$50 000 in each case;

3. <u>Requests</u> the Director Ceneral to submit to the Board periodic statements of advances made from the Fund under the authority given in paragraph 2 above; and

4. <u>Urges</u> Member States that have not yet done so to pay their advances to the Fund as soon as possible.
