# **PROVISIONAL AGENDA**

1. In accordance with Rule 2 of the Rules of Procedure of the General Conference<sup>1/</sup>, the Director General hereby notifies all Members of the Agency that the fortieth regular session of the General Conference will open at the <u>Austria Center Vienna<sup>2/</sup></u> on Monday, 16 September 1996, at 10 a.m.

2. During the weekend preceding the opening of the Conference's session (Saturday, 14 September and Sunday, 15 September 1996), facilities will be made available for group meetings. Member States are strongly urged to avail themselves of those facilities with a view to achieving early agreement on organizational matters and thereby contributing to the smooth running of the session, ensuring - where necessary - that their representatives arrive in Vienna in time to participate in pre-session group meetings and the associated group decision-making. Meeting rooms may be reserved through the Secretariat's Conference Service Section (tel. no.:  $+ 43 \ 1 \ 2060/21323$ ).

3. Pursuant to Rule 11, the Director General has drawn up the attached provisional agenda for the session in consultation with the Board of Governors. In the annotation to each item a suggestion is made, for consideration by the General Committee, as to where it should first be discussed - in plenary or in a committee.

4. Should the Director General receive, by 17 August 1996, any request under Rule 13 for inclusion of a supplementary item in the agenda, such an item will, unless Rule 21 applies, be placed on a list which will be circulated not later than 27 August 1996.

### **ANNOTATIONS**

### 1. Election of officers and appointment of the General Committee<sup>3/</sup>

Under Rule 34 of the Rules of Procedure, the General Conference will be called upon to elect a President. The President will propose for election the names of eight Vice-Presidents and the name of a Chairman of the Committee of the Whole. Also, under Rule 40 the Conference is required to appoint a General Committee consisting of the President, the eight Vice-Presidents, the Chairman of the Committee of the Whole and five additional members elected on the proposal of the President.

### 2. Applications for membership of the Agency Plenary

The Conference will have before it one or more recommendations by the Board of Governors regarding applications for membership of the Agency. Document GC(40)/2contains a Board recommendation regarding an application by the Republic of Moldova.

### 3. Message from the Secretary-General of Plenary the United Nations

It is expected that a message from the Secretary-General of the United Nations will be delivered.

4. Statement by the Director General

The Director General proposes to make a statement to the Conference.

### 5. <u>Arrangements for the Conference</u>

## (a) Adoption of the agenda and allocation <u>General Committee</u> of items for initial discussion

The General Committee is required to report to the Conference under Rule 42(a) on the provisional agenda set forth in the present document and on any supplementary or additional items (Rules 13 and 15). The Conference will then approve the agenda (Rule 14) and allocate the items for initial discussion.

### (b) <u>Closing date of the session and</u> <u>General Committee</u> opening date of the next session

The Conference is required, under Rule 8, to set the closing date of the session and, under Rule 1, to set the opening date of the forty-first (1997) regular session after considering recommendations made by the General Committee.

### 6. <u>Voluntary contributions to the Technical</u> <u>Plenary</u> <u>Co-operation Fund for 1997</u>

Member States will be urged to pledge voluntary contributions to the Technical Cooperation Fund for 1997 and attention will be drawn to the fact that such pledges of contributions can be made during the session.

### 7. General debate and annual report for 1995

Under Article V.E.4 of the Statute, the Conference is required to consider the report for the year 1995 which the Board has prepared (GC(40)/8).

### 8. Election of Members to the Board of Governors

The Conference will be called upon to elect 11 Members to the Board<sup>4/</sup>. Under Rule 83, the President will indicate to the Conference those elective places on the Board which must be filled so as to ensure that after the end of the session the Board will be constituted in accordance with Article VI.A.2 of the Statute. In document GC(40)/7 the Board informs the Conference of the designations it has made for membership on the Board in 1996-97.

### (a) <u>Amendment of Article VI</u>

In resolution GC(39)/RES/21, the Conference requested the Board of Governors to continue consultations with Member States through the existing Openended Consultative Group and to submit its report and recommendations on proposed amendments to Article VI for approval by the General Conference at its fortieth regular session.

It is expected that, following discussion at its June 1996 session, the Board will revert to this matter at its meetings starting on 9 September 1996 and that a report will be before the Conference.

### (b) <u>Composition of regional groups</u> <u>Committee of the Whole</u>

In resolution GC(39)/RES/22, the General Conference requested the Director General "to study all the implications of the proposal contained in document GC(39)/COM.5/10 and submit a report to the Board of Governors." It further requested the Board "to consider this matter and report to the General Conference at its fortieth regular session."

In document GC(40)/11, the Conference will have before it a report by the Board as requested in operative paragraph 2 of the resolution.

20. Implementation of the agreement between the Agency and the Democratic People's Republic of Korea for the application of safeguards in connection with the Treaty on the Non-Proliferation of Nuclear Weapons

This item is included in the provisional agenda pursuant to operative paragraph 5 of resolution GC(39)/RES/3, in which the General Conference decided last year to include in the agenda for its fortieth regular session an item entitled "Implementation of the agreement

between the Agency and the Democratic People's Republic of Korea for the application of safeguards in connection with the Treaty on the Non-Proliferation of Nuclear Weapons".

### 21. An African Nuclear-Weapon-Free Zone

This item is included in the provisional agenda pursuant to resolution GC(39)/RES/4 adopted by the Conference last year. It is expected that the Director General will report to the Conference on the implementation of the resolution as requested in its operative paragraph 2.

# 22. The implementation of United Nations Plenary Security Council resolutions relating to Iraq Plenary

This item is included in the provisional agenda pursuant to resolution GC(39)/RES/5adopted by the General Conference last year. It is expected that, as requested in operative paragraph 8 of the resolution, the Director General will report to the Conference on the implementation of United Nations Security Council resolutions relating to Iraq.

### 23. <u>Application of IAEA safeguards in</u> the Middle East

This item is included in the provisional agenda pursuant to resolution GC(39)/RES/24 adopted by the General Conference last year. The Director General will report to the Conference (in document GC(40)/6) on the implementation of the resolution as requested in its operative paragraph 9.

### 24. Examination of delegates' credentials

Under Rule 28 the General Committee, meeting as a credentials committee, will examine the credentials of all delegates and report thereon to the Conference.

It is expected that the Conference will be called upon to elect one or more members of the Agency's Staff Pension Committee.
