Forty-seventh regular session

Provisional Agenda

- 1. In accordance with Rule 2 of the Rules of Procedure of the General Conference¹, the Director General hereby notifies all Members of the Agency that the forty-seventh regular session of the General Conference will open at the <u>Austria Center Vienna</u>² on Monday, 15 September 2003 at 10.00 a.m.
- 2. During the weekend preceding the opening of the Conference's session (Saturday, 13 September and Sunday, 14 September 2003), facilities will be made available for group meetings. Member States are strongly urged to avail themselves of those facilities with a view to achieving early agreement on organizational matters and thereby contributing to the smooth running of the session, ensuring where necessary that their representatives arrive in Vienna in time to participate in pre-session group meetings and the associated group decision-making. Meeting rooms may be reserved through the Secretariat's Conference Service Section (tel. no.: +43 1 2600/21320).
- 3. Pursuant to Rule 11 of the Conference's Rules of Procedure, the Director General has drawn up the attached provisional agenda for the session in consultation with the Board of Governors. In the annotation to each item a suggestion is made, for consideration by the General Committee, as to where it should first be discussed in plenary or in a committee.
- 4. Should the Director General receive by 16 August 2003 any request under Rule 13 for inclusion of a supplementary item in the agenda, such an item will, unless Rule 21 applies, be placed on a list which will be circulated not later than 26 August 2003.

Annotations

1. Election of officers and appointment of the General Committee³ Plenary

Under Rule 34 of the Rules of Procedure, the General Conference will be called upon to elect a President. In accordance with Rules 34 and 40, the Conference will also be called upon to elect eight Vice-Presidents, a Chairman of the Committee of the Whole and five additional members on the proposal of the President.

2. Applications for membership of the Agency (if any)

Plenary

The General Conference may have before it recommendations by the Board of Governors regarding applications for membership of the Agency.

3. Message from the Secretary-General of the United Nations

Plenary

It is expected that a message from the Secretary-General of the United Nations will be delivered.

4. Statement by the Director General

Plenary

The Director General is expected to make a statement to the Conference.

5. Arrangements for the Conference

(a) Adoption of the agenda and allocation of items for initial discussion

General Committee

The General Committee is required to report to the Conference under Rule 42(a) on the provisional agenda set forth in the present document and on any supplementary or additional items (Rules 13 and 15). The Conference will then approve the agenda (Rule 14) and allocate the items for initial discussion.

(b) Closing date of the session and opening date of the next session

General Committee

The Conference is required, under Rule 8, to set the closing date of the session and, under Rule 1, to set the opening date of the forty-eighth (2004) regular session after considering recommendations made by the General Committee.

6. Contributions to the Technical Co-operation Fund for 2004

Plenary

Member States will be urged to pledge contributions to the Technical Co-operation Fund for 2004 and attention will be drawn to the fact that such pledges of contributions can be made during the session.

7. General debate and Annual Report for 2002

Plenary

Under Article V.E.4 of the Statute, the Conference is required to consider the Agency's Annual Report for the year 2002, which the Board has approved (GC(47)/2).

As part of the efforts to streamline the work of the General Conference, it is recommended that statements by delegates in the general debate be limited to 15 minutes.

As stated in paragraph 2 of the cover note, facilities are being made available for area groups to meet during the weekend preceding the opening of the Conference's session. It is hoped that this measure will help area groups to reach agreement on their nominees for membership of the General Committee <u>before Monday morning</u> so that the work of the Conference can proceed without delay.

8. Election of Members to the Board of Governors

Plenary

The Conference will be called upon to elect 11 Members to the Board⁴. Under Rule 83, the President will indicate to the Conference those elective places on the Board which must be filled so as to ensure that after the end of the session the Board will be constituted in accordance with Article VI.A. of the Statute. Designations made in accordance with Article VI.A.1 of the Statute for membership on the Board in 2003-2004 are set out in document GC(47)/5.

9. The Agency's Accounts for 2002

Committee of the Whole

In accordance with Rule 12(i), the Agency's Accounts for 2002, together with the External Auditor's report thereon and the report of the Board, are being communicated to the Conference in document GC(47)/4.

10. The Agency's Programme and Budget for 2004-2005 Committee of the Whole

Under Article V.E.5 of the Statute, the Conference is called upon to approve the Agency's budget for 2004 which the Board, pursuant to Article XIV.A, is submitting to it in document GC(47)/3.

11. Appointment of the External Auditor

Plenary

The tenure of the Agency's External Auditor will end with the completion of the audit of the Agency's accounts for the financial year 2003⁵. It will therefore be necessary for the Conference to appoint an External Auditor to audit the Agency's accounts for 2004 and 2005. For this purpose, it is expected that the General Conference will have before it a recommendation by the Board.

12. Scale of assessment of Members' contributions towards the Regular Budget

Committee of the Whole

Pursuant to Article XIV.D of the Statute, a proposed scale of assessment of Members' contributions towards the Regular Budget for 2004 will be submitted to the Conference.

13. Restoration of voting rights

Committee of the Whole

By decision GC(46)/DEC/8 the General Conference in 2002 requested the Board of Governors to consider the criteria, guidelines and measures being applied in connection with requests for the restoration of voting rights, in particular the requirements for payment plans, at its meeting in June 2003.

14. Measures to strengthen international co-operation Committee of the Whole in nuclear, radiation and transport safety and waste management

This item is included in the provisional agenda pursuant to resolution GC(46)/RES/9. It is expected that the General Conference will have before it reports on the following issues:

- the safety standards programme;
- the safety of research reactors;
- occupational radiation protection;

The terms of office of Bulgaria, Burkina Faso, Chile, Colombia, Islamic Republic of Iran, Kuwait, Morocco, Philippines, Romania, Spain and Turkey will expire at the end of this year's regular session (see document GC(45)/RES/DEC(2001), decision number GC(45)/DEC/9).

- the decommissioning of nuclear facilities;
- the safety of radioactive waste management;
- the safety and security of radioactive sources;
- the safety of transport of radioactive material;
- the radiological protection of patients;
- radiological criteria relating to long-lived radioisotopes in commodities;
- education and training in nuclear, radiation and transport safety and waste management; and
- the Nuclear Safety Review for the year 2002 (GC(47)/INF/3).

15. Nuclear security – measures to protect against nuclear terrorism

Committee of the Whole

This item is included in the provisional agenda pursuant to resolutions GC(45)/RES/14 and GC(46)/RES/13. It is expected that the General Conference will have before it a report on issues related to nuclear security.

16. Strengthening of the Agency's technical co-operation activities

Committee of the Whole

This item is included in the provisional agenda to enable the Director General to report on the implementation of resolution GC(46)/RES/10 as requested in its operative paragraph 13.

17. Strengthening the Agency's activities related to nuclear science, technology and applications

Committee of the Whole

This item is included in the provisional agenda pursuant to resolutions GC(45)/RES/12 and GC(46)/RES/11. It is expected that the General Conference will have before it reports relating to:

- the Nuclear Technology Review Update 2003;
- Plan for producing potable water economically using small and medium-sized nuclear reactors;
- Use of isotope hydrology for water resources management;
- Servicing immediate human needs;
- Agency activities in the development of innovative nuclear technology;
- Support to the African Union's Pan African Tsetse and Trypanosomosis Eradication Campaign (PATTEC); and
- Maintenance and preservation of nuclear knowledge.

18. Strengthening the effectiveness and improving the efficiency of the safeguards system and application of the Model Additional Protocol

Committee of the Whole

This item is included in the provisional agenda pursuant to resolution GC(46)/RES/12 to enable the Director General to report on the implementation of the resolution as requested in its operative paragraph 16.

19. Implementation of the NPT safeguards agreement between the Agency and the Democratic People's Republic of Korea

Plenary

This item is included in the provisional agenda pursuant to operative paragraph 8 of resolution GC(46)/RES/14, in which the General Conference decided last year to remain seized of this matter and to include this item in the agenda for its forty-seventh regular session.

20. Implementation of United Nations Security Council resolutions relating to Iraq

Plenary

This item is included in the provisional agenda pursuant to resolution GC(46)/RES/15 adopted by the General Conference last year. As requested in operative paragraph 8 of the resolution, the Director General will report to the Conference on his efforts to implement relevant United Nations Security Council resolutions relating to Iraq.

21. Application of IAEA safeguards in the Middle East

Plenary

This item is included in the provisional agenda pursuant to resolution GC(46)/RES/16 adopted by the General Conference last year. The Director General will report to the Conference on the implementation of the resolution as requested in its operative paragraph 9.

22. Israeli nuclear capabilities and threat

Plenary

This item has been included in the provisional agenda at the request of Arab States members of the Agency, as forwarded by the Sultanate of Oman. An explanatory memorandum, required under Rule 20 of the Rules of Procedure of the General Conference will be before the Conference.

23. Personnel

Committee of the Whole

(a) Staffing of the Agency's Secretariat

This sub-item is included in the provisional agenda to enable the Director General to report on the implementation of resolution GC(45)/RES/15.A. as requested in operative paragraph 3.

(b) Women in the Secretariat

This sub-item is included in the provisional agenda to enable the Director General to report on the implementation of resolution GC(45)/RES/15.B. as requested in operative paragraph 5.

24. Examination of delegates' credentials

General Committee

Under Rule 28 of the Rules of Procedure the General Committee, meeting as a credentials committee, will examine the credentials of all delegates and report thereon to the Conference.

25. Report on contributions pledged to the Technical Co-operation Fund for 2004

Plenary

It is expected that pledges of contributions to the Technical Co-operation Fund for 2004 will be obtained during the Conference and that the President will communicate a report thereon to the Conference.
