#### Supplementary item for inclusion in the provisional agenda

#### **Explanatory Memorandum**

In September 2021, the US, the UK and Australia announced the creation of AUKUS, under which the US and the UK will support Australia's acquisition of nuclear powered submarines.

The AUKUS nuclear submarine cooperation marks the first time in history for Nuclear-Weapon States to transfer nuclear powered submarine reactors and weapons-grade highly enriched uranium to a Non-Nuclear-Weapon State as their military ally. Such cooperation poses serious challenge to the NPT regime and IAEA comprehensive safeguards system. It is clearly not a routine and peaceful safeguards project between Non-Nuclear-Weapon State and the IAEA Secretariat. In that context, Australia's request to commence negotiations with the Agency on an arrangement required under Article 14 of the Comprehensive Safeguards Agreement is unprecedented, and involves a series of controversial issues.

Since November 2021, the intergovernmental discussions about AUKUS have continuously deepened. The IAEA Board of Governors and the General Conference has placed "Transfer of the nuclear materials in the context of AUKUS and its safeguards in all aspects under the NPT" on agenda for eighteen consecutive times. There were also serious discussion among States Parties during the NPT review process. Various aspects and impacts of the AUKUS cooperation were reviewed in the above discussions, including its impact on the historical practice of IAEA in improving and strengthening the safeguards system, as well as the importance of adhering to the tradition of inclusiveness and consensus in this regard. More and more Member States have realized that the AUKUS issue concerns the interests of all.

All of the above fully demonstrates the importance and necessity of a continuing intergovernmental discussion process on AUKUS. Therefore, it is the hope of the Chinese Delegation that IAEA Member States could continue to advance the open, inclusive and transparent intergovernmental discussion at the 69<sup>th</sup> General Conference, with a view to facilitating all the parties in expressing their views and concerns, upholding the IAEA safeguards system as well as the international nuclear non-proliferation regime.
