

SUMMARY OF MEETINGS

held on Friday, 25 September 2020

Plenary 11th meeting

Under agenda item 21 "Israeli nuclear capabilities", statements were made by Azerbaijan (on behalf of the Non-Aligned Movement), Germany (on behalf of the EU), Jordan (on behalf of the Arab Group), Lebanon, the Syrian Arab Republic, the United States of America, Egypt, Iraq, Indonesia, Cuba, the Islamic Republic of Iran, the United Kingdom of Great Britain and Northern Ireland, and Israel.

Plenary 13th meeting

Under agenda item 19, "Implementation of the NPT safeguards agreement between the Agency and the Democratic People's Republic of Korea", the Conference adopted the draft resolution contained in document GC(64)/L.3.

Under agenda item 25, "Report on contributions pledged to the Technical Cooperation Fund for 2021" (document GC(64)/17/Rev.1), the President gave a statement.
