The Federal Republic of Yugoslavia became a new Member on 31 October 2001 and changed its name to "Serbia and Montenegro" on 4 February 2003. With the Declaration of Independence of Montenegro on 3 June 2006, the membership of Serbia and Montenegro was continued by the Republic of Serbia.
