* AMERICAN AUTHORITIES IN LAUNCHING A SUSPICIOUS DRIVE OF
* FALSIFICATIONS WITH THE OBJECT OF DISTORTING IRAQ'S REPUTATION AND

* IN A STATEMENT HERE TODAY, THE SPOKESMAN SAID THAT WITH THIS

* PURPOSES. THE CONTRACT VALUED ONLY 10500 DOLLARS.

* THE SPOKESMAN ADDED THAT AMERICAN AUTHORITIES IN COOPERATION WITH
* THE BRITISH ONES, AS ADMITTED BY THE SAID QUARTERS, SLIPPED ON
* PURPOSE AN AGENT FROM THE F.B.I. IN THE AMERICAN COMPANY THAT SUPPLY
* THOSE MATERIALS UNDER THE PRETEXT OF BEING DIRECTOR OF THE PURCHASES
* TO MAKE THIS SMALL AND NORMAL DEAL A SUSPICIOUS INTELLIGENCE

* WITH HIGH VOLTAGE CAPACITORS FOR THEIR USE IN THIS SYSTEM. AN OFFER
* BY THE BRITISH COMPANY EUROMAC WAS ACCEPTED IN MAY 1984 FOR
* OBTAINING 85 CAPACITORS AT A TOTAL COST OF 10500 DOLLAR.

والامان في التعامل وطلب تأمين نقطة ايمال في الولايات المتحدة الامريكية وهو ما تم التأكد عليه من قبله بشكل مركز (الملاحق ٤) .

* وقد دهن الجانب العراقي لما ورد بمضمون البرقية اعلاه واعرب عن احتجاجه للمجهز بالاتمال الهاتفي، ولما لم تتسلم شركة (CSI) اي جواب برقي من الجانب العراقي وعرفت بأن محاولتها املت ارسلت برقية اخرى الى الجانب العراقي في يوم ٢٢ كانون الثاني ١٩٩٠ (الملاحق رقم ٥) . وكانت تتعلق بموضوع المتسمات كما وردت في الطلب هذه المرة ، فخير ان الشركة اشارت في آخر البرقية الى عرض (لمعدات اخرى) مع تحذير من كشفها من قبل السلطات الامريكية .

* وتمت الاجابة على هذه البرقية بشكل روتيني بهموس المتسمات ، ولكن الجواب تضمن ايضا ما يأتي :
" عند شراء اي شي منكم ، سنعمل ذلك ونسوق اجراءاتكم الاعتيادية " (الملاحق رقم ٦) .
