

FAQs

Q.1 Where in the venue will the WFEG meeting take place?

The WFEG and the IAEA's Fusion Energy Conference (FEC) will be held at the same venue. The two events will proceed with a joint opening session in the same hall, after which they will split into separate halls and run in parallel.

- **Joint Opening Ceremony:** Sichuan Hall
- **World Fusion Energy Group (WFEG):** Chengdu Hall
- **Fusion Energy Conference (FEC):** Will continue in the Sichuan Hall after the opening.

Q.2 Who can be part of a national delegation?

Invited addressees from member states are expected to constitute their national delegation (headed by him/her or a designated high-level political entity), which may include appropriate representation from relevant public institutions dealing in fusion energy (e.g. National Research Institutions, Policymakers, Regulators, etc.).

Q.3 How can I register my national delegation?

- **Delegation Information:** Organization, Full Name (specifying Given Name, Surname), Role/Office, Nationality, Passport number.
- **Arrival and Departure Details:** Date, time, airport of arrival and departure, and flight number.

Q.4 What is the registration deadline?

The dates given in various communications are indicative. It serves as a guideline rather than a strict cutoff. But it is very important that the registrations are completed at the earliest to facilitate the logistics for travel and other arrangements.
