Plenary 3rd meeting

The Conference resumed consideration of agenda **item 7** of the agenda, "General debate and Annual Report for 2024", and statements were made by the delegates of Kyrgyzstan, the United Kingdom of Great Britain and Northern Ireland, Spain, Lithuania, Estonia, Botswana, Liberia, Cuba, Djibouti, the United Republic of Tanzania, Ghana, Bulgaria, Monaco, Bosnia and Herzegovina, Philippines, Poland, Czech Republic, South Africa, Switzerland, Germany, Canada, Sweden, Holy See, Latvia and Bangladesh.
