

SUMMARY OF MEETINGS

held on Friday, 19 September 2025

Plenary 10th meeting

The Conference took up **item 23** of the agenda, "Transfer of the nuclear materials in the context of AUKUS and its safeguards in all aspects under the NPT" and statements were made by China, Australia on behalf of the AUKUS partners, Denmark on behalf of the European Union, Pakistan, Nicaragua, the Russian Federation, the Bolivarian Republic of Venezuela, Egypt, Zimbabwe, Cuba, Japan, the Republic of Korea and the Islamic Republic of Iran. China exercised its right of reply.

The Plenary was suspended to allow more time for consultations on agenda item 8.

The Conference resumed and took up **item 8** of the agenda, "Election of members to the Board of Governors". The Conference elected without a vote Belgium, Chile, Jordan, Lithuania, the Niger, Peru, the Philippines, Portugal, Romania, Saudia Arabia and Togo to serve on the Board of Governors from the end of this regular session of the Conference until the end of the seventy-first regular session in 2027. A statement was made by Kazakhstan.

The Conference took up **item 24** of the agenda "Restoration of the sovereign equality of Member States in the IAEA" and statements were made by Kazakhstan, Ghana on behalf of the African Group, Egypt on behalf of the Arab Group, Uzbekistan on behalf of a group of Member States, Belarus, Indonesia, China, Azerbaijan, the Bolivarian Republic of Venezuela, the Russian Federation, the Philippines, Egypt and the United Kingdom.

Committee of the Whole 8th Meeting

Under agenda **item 16**, "Strengthening the Agency's activities related to nuclear science, technology and applications", the Committee agreed to recommend to the Conference for adoption:

- the draft resolution entitled "Nuclear power applications", contained in document GC(69)/COM.5/L.4/Rev.1; and
- the draft resolution entitled "Non-power nuclear applications Support to the African Union's Pan African Tsetse and Trypanosomosis Eradication Campaign (AU-PATTEC)", contained in document GC(69)/COM.5/L.6.
- the draft resolution entitled "Non-power nuclear applications Zoonotic Disease Integrated Action (ZODIAC) Project", contained in document GC(69)/COM.5/L.5; and
- Under agenda **item 27**, "Personnel Staffing of the Agency's Secretariat, contained in document GC(69)/COM.5/L.10, and Women in the Secretariat", contained in document



GC(69)/COM.5/L.8.

The Committee also considered under:

- agenda **item 15**, "Strengthening of the Agency's technical cooperation activities", a draft resolution contained in document GC(69)/COM.5/L.3;
- agenda **item 16**, "Strengthening the Agency's activities related to nuclear science, technology and applications" the draft resolution entitled "Non-power nuclear applications General", contained in document GC(69)/COM.5/L.12; and
- agenda **item 17**, "Strengthening the effectiveness and improving the efficiency of Agency safeguards", a draft resolution contained in document GC(69)/COM.5/L.1.

The Conference took up **item 29** of the agenda, "Report on contributions pledged to the Technical Cooperation Fund for 2026". It was reported that there was an increase in pledges compared with the number of pledges at the same time last year. The total amount pledged, by that time, was 36 990 933 euros or 37.75% of the target for 2026.

The Chair of the Committee of the Whole presented the Committee's final report on the outcome of deliberations and presented the Committee's recommendations to the Conference.

Under **item 13** of the agenda "Nuclear and radiation safety" the Conference adopted the draft resolution contained in document GC(69)/L.8.

Plenary 11th meeting

Under **item 16** of the agenda "Strengthening the Agency's activities related to nuclear science, technology and applications" the Conference adopted the draft resolutions contained in document GC(69)/COM.5/L.6/Rev.1 entitled "Support to the African Union's Pan African Tsetse and Trypanosomosis Eradication Campaign (AU-PATTEC)"; in document GC(69)/COM.5/L.5/Rev.1 entitled "Zoonotic Disease Integrated Action (ZODIAC) Project"; and in document GC(69)/COM.5/L.4/Rev.2 entitled "Nuclear power applications".

Under item 27 of the agenda, "Personnel", the Conference adopted the draft resolution contained in document GC(69)/L.12.

The Committee of the Whole was not able to make a recommendations on the following draft resolutions:

Under item 15 of the agenda, the draft resolution contained in document GC(69)/COM.5/L.2 entitled "Strengthening of the Agency's technical cooperation activities".

Under **item 16** of the agenda, the draft resolution contained in document GC(69)/COM.5/L.12 entitled "Strengthening the Agency's activities related to nuclear science, technology and applications".

Under **item 17** of the agenda, the draft resolution contained in document GC(69)/COM.5/L.1 entitled "Strengthening the effectiveness and improving the efficiency of Agency safeguards".

As the Chair of the Committee of the Whole reported, there was a proposal in the Committee that for each of the draft resolutions that were not recommended by the Committee to the Plenary for adoption, the President of the Conference may read the following statement:

"I wish to inform the Conference that with regard to item [...] the provisions of the resolution GC(68)/RES/.... remain valid and that the Director General will report, as appropriate, on the implementation of that resolution to the 70th regular session of the General Conference".

The President addressed the remaining items. The President expressed his gratitude for the cooperation and the assistance extended to him and for the valuable support, which enabled the successful completion of the work of the Conference. Statements were made by the Republic of Korea and the Islamic Republic of Iran.
