

# **SUMMARY OF MEETINGS**

# held on Wednesday, 27 September 2023

#### Plenary 5th meeting

The Conference resumed consideration of **item 7** of the agenda, "General debate and Annual Report for 2022". Statements were made by India, Algeria, Senegal, New Zealand, Indonesia, Belarus, the United Arab Emirates, Serbia, Georgia, Luxembourg, Canada, Australia, Greece, Yemen, Peru, Ireland, Sri Lanka, the Philippines, Portugal, Oman, Romania, Uruguay and Norway.

#### Committee of the Whole 4th meeting

The Committee continued discussions under agenda **item 13**, "Nuclear and radiation safety", on the draft resolution contained in document GC(67)/COM.5/L.12.

The Committee took up **item 23** of the agenda, "Restoration of sovereign equality in the IAEA", and began consideration of the draft resolution contained in document GC(67)/COM.5/L.14.

The Committee also took up **item 26** of the agenda, "Amendment of Article VI of the Statute", and agreed to recommend to the Conference for adoption the decision set out in document GC(67)/COM.5/L.15.

The Committee commenced discussions under agenda **item 14**, "Nuclear security", and began consideration of the draft resolution contained in document GC(67)/COM.5/L.11 and the amendments thereto proposed in document GC(67)/COM.5/L.13

# Plenary 6th meeting

The Conference resumed consideration of **item 7** of the agenda, "General debate and Annual Report for 2022". Statements were made by Kuwait, Nepal, Colombia, El Salvador, Guatemala, Finland, Paraguay, Costa Rica, Nicaragua, Ecuador, Armenia, Angola, Lebanon, Côte d'Ivoire, Cuba, Jamaica, Croatia, Afghanistan, Diibouti, Panama, Bahrain and Cyprus.

#### Committee of the Whole 5th

meeting

The Committee continued discussions under agenda **item 14**, "Nuclear security", on the draft resolution contained in document GC(67)/COM.5/L.11 and document GC(67)/COM.5/L.13.

Under agenda **item 22**, "Promotion of Efficiency and Effectiveness of the IAEA Decision Making Process", the Committee agreed to provide the report by the Chair of the Committee on the discussions to the Plenary.

# Committee of the Whole 6th meeting

Owing to ongoing consultations on several items, it was decided to resume the discussions in the next meeting.

## Plenary 7th meeting

The Conference resumed consideration of **item 7** of the agenda, "General debate and Annual Report for 2022". Statements were made by Zambia, Turkmenistan, Libya, the Republic of Moldova, Kenya, the Bahamas, Zimbabwe, Rwanda, the Lao People's Democratic Republic, Lesotho, Iceland and Palestine, the European Atomic Energy Community (Euratom), the International Criminal Police Organization (INTERPOL), the Agency for the Prohibition of Nuclear Weapons in Latin America and the Caribbean (OPANAL), the Sovereign Order of Malta, the Brazilian–Argentine Agency for Accounting and Control of Nuclear Materials (ABACC), the Comprehensive Nuclear Test-Ban Treaty Organization (CTBTO), the African Commission on Nuclear Energy (AFCONE) and the Arab Atomic Energy Agency (AAEA). The United Kingdom of Great Britain and Northern Ireland (on behalf of France, the United Kingdom of Great Britain and Northern Ireland, and the United States of America), and the Islamic Republic of Iran exercised their right of reply.
