

# **SUMMARY OF MEETINGS**

**held on Friday, 29 September 2023**

**Plenary  
11th  
meeting**

The Conference adopted the following draft resolutions which had been presented by the Chair of the Committee of the Whole in his interim report:

- under **item 9** of the agenda, “The Agency’s Financial Statements for 2022”, the draft resolution contained in document GC(67)/4;
- under **item 10** of the agenda, “The Agency’s Programme and Budget 2024–2025”, the draft resolutions in document GC(67)/5 entitled “Regular Budget Appropriations for 2024”, “Technical Cooperation Fund Allocation for 2024” and “The Working Capital Fund for 2024”;
- under **item 11** of the agenda, “Amendment to Article XIV.A of the Statute”, the decision contained in document GC(67)/L.4;
- under **item 12** of the agenda, “Scale of assessment of Member States’ contributions towards the Regular Budget for 2024”, the resolution on page 3 of document GC(67)/12/Rev.1;
- under **item 15** of the agenda, “Strengthening of the Agency’s technical cooperation activities”, the draft resolution contained in document GC(67)/L.8; and
- under **item 16** of the agenda, “Strengthening the Agency’s activities related to nuclear science, technology and applications”, the draft resolutions contained in document GC(67)/L.3.

Under **item 22** of the agenda, “Promotion of Efficiency and Effectiveness of IAEA Decision Making Process”, the Conference took note of the report of the Chair of the Committee of the Whole.

Under **item 23** of the agenda, “Restoration of sovereign equality in the IAEA”, the Statements were made by Kazakhstan, Azerbaijan, Nepal, the United Kingdom of Great Britain and Northern Ireland, the Russian Federation, the Islamic Republic of Iran, the Syrian Arab Republic, the United States of America, Slovenia, Mexico, the Bolivarian Republic of Venezuela, Ireland, Egypt, Spain (on behalf of the European Union), South Africa, Switzerland, Pakistan and Sweden.

The Conference did not approve some proposed amendments to preambular paragraph (d), to operative paragraph 1 or to operative paragraph 2 of the draft resolution contained in document GC(67)/COM.5/L.14.

The Conference adopted by a vote the draft resolution contained in document GC(67)/COM.5/L.14. Statements were made by Jordan, Pakistan, the Syrian Arab Republic, India, Guatemala, Morocco, the Russian Federation, Egypt, Côte d’Ivoire, Japan and Kazakhstan.

Under **item 26**, “Amendment to Article VI of the Statute”, the Conference adopted the draft decision contained in document GC(67)/L.7. Statements were made by the Republic of Korea and Slovenia.

Under **item 27**, “Personnel”, the Conference adopted the draft resolution contained in document GC(67)/L.9.

The Conference considered agenda **item 18**, “Implementation of the NPT safeguards agreement between the Agency and the Democratic People’s Republic of Korea”, and adopted the draft resolution contained in document GC(67)/L.6. Statements were made by Canada and the Russian Federation.

- under agenda **item 13**, “Nuclear and radiation safety”, the draft resolution set out in document GC(67)/COM.5/L.12/Rev.3; after the adoption of draft resolution, statements were made by Norway, the Philippines, Canada, Costa Rica, Ireland, Sweden, France, Spain, Finland, Honduras, Uruguay, the United States of America, Chile, Mexico, Germany, Australia, South Africa, South Africa, Colombia, Italy, the Islamic Republic of Iran, Argentina and Pakistan; and
- under agenda **item 14**, “Nuclear Security”, the draft resolution set out in document GC(67)/COM.5/L.11/Rev.2.

Under agenda **item 17**, “Strengthening the effectiveness and improving the efficiency of Agency Safeguards”, the draft resolution contained in document GC(67)/COM.5/L.8/Rev.2. After the adoption of the draft resolution, statements were made by India and Pakistan.
